The issuance of this certificate is the first step in recognising that industry players bear the responsibility of their products' lifecycles and should be moving the needle in achieving sustainable product outcomes, aligned with circular economy principles. The collective understands that shifting the responsibility for collection, transportation, and management of products away from local governments to the manufacturers and producers is needed to accelerate solutions to more effective, fair, and efficient methods of resource consumption, as well closing the loop on wasted materials and energy.

The collective plays an important role in providing a just transition to meet the growing needs of our future generations.

ABOUT THE-S-NETWORK:

The Textile & Household Items Environmental Product Stewardship Network (THE-S-NETWORK) is a voluntary collective, championed by Upcycle4Better (U4B) to share the responsibility of reducing the environmental, health and safety footprint of manufactured goods and materials across the life cycle of a consumer textile product, including material streams, among textile and apparel manufacturers, producers, retailers, transporters, designers, consumers, as well as reverse collection systems.

Life Line Clothing Malaysia (LLCM) and Australian Textiles Manufacturing Malaysia (ATMM), based in Port Klang, Malaysia, have a long history of collecting, sorting, distributing, reuse, recycling, and reselling consumer textile products. They are the appointed operators in this region responsible for transitioning the current framework into one that promotes the longevity of textile products within the economy. Through their collection bins dotted across the country, they are a 'Reverse Logistics Provider' that ensures no consumer textiles goes to landfill.

THE PRINCIPLES OF THE-S-NETWORK (TEXTILES & HOUSEHOLD ENVIRONMENTAL STEWARDSHIP NETWORK) ARE:

- 1) Producer Responsibility:** All producers selling consumer textile products ("the product") are responsible for either designing, participating, and/or financing a stewardship program that addresses the life cycle impacts of their products, including end-of-life management. This includes the collection, transportation, and responsible reuse, recycling or disposition of the said products, with minimum government involvement.
- 2) Shared responsibilities:** Retailers must look to only sell products from producers who are also in compliance with stewardship requirements. State and local governments work with producers on educating the public about stewardship programs. Consumers are responsible for using return systems setup by producers or reverse logistics providers.
- 3) Governance:** The Government sets goals and performance standards across industry with consultation with stakeholders, as well as setting up policy frameworks and legislation, monitor stewardship performance, and disclosing environmental outcomes.
- 4) Financing:** Producers finance their stewardship programs as a general cost of doing business, through cost internalisation or recovering costs through arrangements with their distributors or retailers. End-of-life fees are not allowed.
- 5) Environmental Protection:** Members of the ESN should address environmental product design, including designing out waste, pollution reduction, resource efficiency, recyclability, and reducing toxicity of products, as well as enhanced safety.

BY MAKING 'THE-S-NETWORK' A REALITY, WE WISH THE CONSUMER TEXTILE PRODUCTS SECTOR TO ACHIEVE THE FOLLOWING BENEFITS:

- 1) A competitive advantage because the public knows that our industry has worked to reduce the negative impacts from our products or by-products
- 2) Demonstrated commitment and results for our stakeholders and when working with governments
- 3) Maximising the value of products and material streams; and
- 4) The availability and build-ability of knowledge to promote and enhance product stewardship schemes for others.

U4B will take the lead in ensuring the THE-S-NETWORK vision and functions are maintained.

U4B work with its members on achieving its objectives.
